Notification pursuant to Article 3 of the Convention on Environmental Impact Assessment in a Transboundary Context (Espoo Convention) regarding a planned offshore wind farm in the Sea of Bothnia in Sweden's economic zone, OWF Aurum.

According to article 3 point 1 of the Espoo Convention, affected countries shall be notified and consulted on projects that are likely to cause transboundary environmental impacts. As a party of origin, Sweden hereby notifies Finland regarding the plans for the potential establishment of an offshore windfarm (OWF) called "Aurum", located in the Bothnian Sea.

## Information on the project

The developer, Aurum Offshore AB (part of Eolus Vind AB) plans to apply for a permit to construct a OWF located in Swedish territorial waters in the Bothnian Sea approximately 3 km outside Robertsfors and Skellefteå municipality, Västerbotten County.

The project area for the wind farm is divided into two areas. The northern project area is approximately 152 km2 and the southern is approximately 198 km2. Within these two areas, the developer plans for up to 147 wind turbines with a maximum total height of 365 m. The installed power is estimated to amount to approx. 2,200 MW, which would mean an annual addition of approx. 8.4 TWh of renewable electricity to the Swedish electricity grid.

Future permit applications with associated EIA will be designed based on input received from consultations, to make possible delimitations of the investigation area for the OWF and investigation corridors for cables.
